#### **BOARD TO CONSIDER APPROVAL OF** FISCAL YEAR 2024 LOCAL FUNDS BUDGET

#### **Report:**

For the past ten years the college has focused on increasing its local funds balances in order to build a reserve to accommodate future capital projects without the necessity of state appropriations. The college has pursued this strategy by several methods including: 1) Reversing the trend of declining locality contributions by requesting small increases in existing funding; 2) Eliminating the use of local funds for expenses that can be paid with state funds; 3) Increasing the non-mandatory fees. This strategy enabled the college to devote over \$700,000 of local funds to the renovation of the Manufacturing and Engineering Technologies Complex (the "MET"). It has also enabled the college to contribute \$1,300,000 for renovation of the MET II.

Locality Fund. The college has been successful in obtaining modest increases in locality contributions. Patrick County reduced its contribution by 70% in 2023. Accordingly, the college anticipates Locality Fund revenues to be flat for FY24. The College anticipates spending \$50,000 for a terrazzo floor in the fover of the MET II building.

Auxiliary Fund. The college anticipates that bookstore commissions and vending commission revenues for fiscal 2024 to be essentially flat. The college anticipates transferring \$35,000 from Auxiliary Funds to support increased Student Activities.

Student Activities Fund. Traditionally, this fund has been augmented by transfers from the Auxiliary Fund. The college's FY 2024 budget reserves a transfer of \$35,000 to Student Activities and provides for substantial foundation support. Student Activities expenses for FY 2023 were substantially higher, due to the resumption of athletics and student activities.

Parking Fund. The college anticipates FY24 revenues of \$50,000.00. The college does not anticipate any parking lot or sidewalk repairs during the upcoming fiscal year. However, the college has budgeted \$25,000.00 as a contingency.

#### **Recommendation:**

It is the recommendation of the college administration that the Board approve the Local Funds Budget for fiscal year 2024.

#### **BOARD TO CONSIDER APPROVAL OF ASSOCIATE OF APPLIED SCIENCE:** MOTORSPORTS TECHNOLOGY PROGRAM

#### **Report:**

Patrick & Henry Community College is proposing an Associate of Applied Science: Motorsports Technology program. According to the Bureau of Labor Statistics data, the employment of Motorsports Technology is a stable industry with more than 5,000 jobs in the performance racing and fabrication region between P&HCC and Charlotte, NC. Average wages exceed \$30/hr and consist of jobs such as Assemblers and Fabricators, Electrical and Electronic Equipment Assemblers, and Team Assemblers. Employment in this field has increased 3.8% YoY and unemployment in Motorsports is 10% below the national average. Coupled together, Motorsports is a promising field that can provide immediate and long-term employment with family sustaining wages.

#### **Recommendation:**

It is the recommendation of the college administration that the Board approve the Associate of Applied Science: Motorsports Technology Program.

#### Length: 67 credits

**Purpose:** To provide a rapid response to an anticipated workforce shortage for the motorsports industry within the mid-Atlantic region. The student will be engaged in mastering the academic and technical skill sets required for employment.

**Employment Objective:** Employment opportunities for graduates of this program include chassis technician, set-up assistant, crew member, block assembly assistant, engine builder, or engine machine technician in racing environments.

**Program Learning Outcomes**: Upon completion of the AAS in Motorsports Technology, graduates will be able to:

- 1. Demonstrate knowledge of auto racing and race vehicles, their characteristics, specifications, rules, regulations, systems, current technology, and testing methods.
- 2. Demonstrate knowledge about components, systems, configuration, classification, terminology, and principles of functioning of high-performance engines used in race competitions.
- 3. Demonstrate the ability to assemble, test, and apply corrective methods to resolve technical issues related to maximum power performance of race engines.
- 4. Demonstrate knowledge of aerodynamics, stability, and control of race vehicles, and the ability to design, model, and fabricate structures and bodies of race vehicles using blueprints and safety specifications.
- 5. Demonstrate knowledge of engineering materials, manufacturing processes, testing techniques, fabricate and/or assemble suspension, traction, steering and braking systems of race vehicles.

#### MTH 111 - Basic Technical Mathematics

Provides a foundation in mathematics with emphasis in arithmetic, unit conversion, basic algebra, geometry and trigonometry. This course is intended for CTE programs. Lecture 3 hours. Total 3 hours per week. 3 credits

**SOC EEE - Social Sciences Elective -** Social Sciences Electives (SOC EEE) Credits: 3

#### CST 110 - Introduction to Human Communication

Examines the elements affecting human communication in individual (e.g., intrapersonal, interpersonal), small group, and public communication contexts with an emphasis on the practice of communication skills in each context. The assignments in the course require college-level reading and analysis of scholarly studies and coherent communication through written reports including the production of at least one APA/MLA-formatted individual writing assignment. This is a UCGS transfer course.

Lecture 3 hours. Total 3 hours per week. 3 credits

#### Eng 115 - Technical Writing

Develops ability in technical writing through extensive practice in composing technical reports and other documents. Guides students in achieving voice, tone, style, and content in formatting, editing, and graphics. Introduces students to technical discourse through selected reading. This course applies to career/technical education (cte) programs. Eng 113 serves both transfer and cte programs.

Lecture 3 hours per week. 3 credits

#### **Description of Program Requirements Courses**

#### MAC 121 - Numerical Control I

Focuses on numerical control techniques in metal forming and machine processes. Includes theory and practice in lathe and milling machine computer numerical control program writing, setup and operation. Part I of II.

Lecture 1-2 hours. Laboratory 2-3 hours. Total 3-5 hours per week. 2-3 credits

#### MAC 161 - Machine Shop Practices I

Introduces safety procedures, bench work, hand tools, precision measuring instruments, drill presses, cut-off saws, engine lathes, manual surface grinders, and milling machines. Part I of II. Lecture 2 hours. Laboratory 2-3 hours. Total 4-5 hours per week. 3 credits

#### MTS 120 - Introduction to Motorsports Technology

Introduces the student to a survey of the Motorsports Industry. Explores the student to a broad overview of the industry, terminology and technology associated with developing a competition racecar. Lecture 3 hours per week.

3 credits

#### MTS 125 - Motorsports Technology I

Introduces the student to the various systems of the racecar. Focuses on the inter-related functions and the theoretical concepts of the high performance race engine. Emphasizes handson skills with identification and installation of component parts of a race engine. Lecture 2 hours. Laboratory 2 hours. Total 4 hours per week. Prerequisite: MTS 120. 3 credits

#### MTS 130 - Motorsports Structural Technology I

Introduces the student to the basic design and fabrication of a racecar. Develops skills for use of the tools, equipment, and materials in the production of a racecar. Emphasizes safety, accuracy, and aesthetics of the racecar and the work environment.

Lecture 2 hours. Laboratory 2 hours. Total 4 hours per week.

Prerequisites: MTS 125 and WEL 130.

3 credits

#### MTS 131 - Motorsports Structural Technology II

Introduces the student to the design and fabrication of a roll cage. Develops skills in the use or tools, equipment, and materials selection to bend, form, and fabricate the primary structural safety component. Emphasizes NASCAR and other sanctioning bodies' specifications. Lecture 1 hour. Laboratory 4 hours. Total 5 hours per week. Prerequisite: MTS 130. 3 credits

#### MTS 132 - Motorsports Structural Technology III

Introduces the student to the design and fabrication of body parts. Develops skills in the use of tools, equipment, and materials selection to bend, form, and fabricate the primary structural safety component. Emphasizes NASCAR and other sanctioning bodies' specifications. Lecture 1 hour. Laboratory 4 hours. Total 5 hours per week. Prerequisite: MTS 130 and MTS 131. 3 credits

#### MTS 135 - Sheet Metal Fabrication

Introduces sheet metal terminology, fabrication, and installation for covering structural framework of race cars. Provides project oriented, problem-based experiences with equipment and machinery used in the Motorsports industry.

Lecture 2 hours. Laboratory 2 hours. Total 4 hours per week. 3 credits

#### MTS 140 - Stock Car Engines I

Provides a comprehensive study concerning all areas of race engines including cylinder block configuration and classification. Covers principles of race engine operation and subsystems. Includes lubrication systems (both wet and dry sump) and specialized cooling systems. Lecture 2 hours. Laboratory 2 hours. Total 4 hours per week. 3 credits

#### MTS 150 - Engine Machining Processes I

Introduces general machining techniques and practices relating to engines and fabrication of Stock Car engine parts. Includes applied mathematic operations found in machining race engines.

Lecture 2 hours. Laboratory 4 hours. Total 6 hours per week. 4 credits

#### MTS 210 - Race Car Setup I

Introduces the student to basic chassis geometry. Develops skills to square the wheelbase, set ride heights, and establish proper weight distribution. Emphasizes teamwork, communication of settings, and accuracy in set up.

Lecture 2 hours. Laboratory 2 hours. Total 4 hours per week.

Prerequisite: MTS 131.

3 credits

#### MTS 211 - Race Car Setup II

Exposes the student to advanced racecar geometry. Develops skills to engage in on-track adjustments for top performance of the vehicle. Emphasizes application of skills on-site and under race conditions.

Lecture 1-2 hours. Laboratory 4 hours. Total 5-6 hours per week. Prerequisite: MTS 210. 3-4 credits

#### MTS 240 - Stock Car Engines II

Introduces the student to the engine short block assembly and proper machining of the cylinder block. Employs various machining techniques needed to bore final size, relieve pressure, and lighten the cylinder block for assembly.

Lecture 1 hour. Laboratory 4 hours. Total 5 hours per week.

Prerequisite: MTS 140 and MTS 150.

3 credits

#### **MTS 250 - Engine Machining Processes II**

Introduces the student to comprehensive machining techniques related to engine and fabrication processes of race engine parts. Demonstrates and performs modern CNC machining operations for race engines. Lecture 1 hour. Laboratory 4 hours. Total 5 hours per week.

Prerequisite: MTS 150, MTS 140. 3 credits

#### MTS 295 - Topics In

Provides an opportunity to explore topical areas of interest to or needed by students. May be used also for special honors courses. May be repeated for credit. Variable hours. 3 credits

#### MTS 298 - Seminar and Project

Requires completion of a project or research report related to the student's occupational objectives and a study of approaches to the selection and pursuit of career opportunities in the field. May be repeated for credit. Variable hours. 3 credits

#### WEL 135 - Inert Gas Welding

Introduces practical operations in use of inert gas shielded arc welding. Studies equipment operation, setup, safety and practice of GMAW (MIG) and GTAW (TIG). Lecture 1 hour. Laboratory 3 hours. Total 4 hours per week. 2 credits

#### SDV 100 - College Success Skills

Assists students in transition to colleges. Provides overviews of college policies, procedures, curricular offerings. Encourages contacts with other students and staff. Assists students toward college success through information regarding effective study habits, career and academic planning, and other college resources available to students. May include English and Math placement testing. Strongly recommended for beginning students. Required for graduation. Lecture 1-3 hours per week.

Dear Dr. Morrissey:

As chair of the Patrick & Henry Community College Board, I am writing to provide our assessment of Dr. Greg Hodges as president for academic year 2022/2023.

Dr. Hodges has the full support and respect of the entire P&HCC Board as well as the administration, faculty, and staff. Importantly, he maintains a place of profound respect within our community and is deeply engaged with the economic development efforts associated with our service region. He is also at the forefront of the many initiatives in which P&HCC makes an impact for our community and our students. Because of his leadership, our fiscal management remains strong.

The local board began the year by approving the P&HCC strategic plan presented by President Hodges which focuses on closing opportunity gaps and achieving excellence for all students regardless of race/ethnicity, gender, or socioeconomic status. With an intentional alignment with *Opportunity 2027* from the VCCS, the P&HCC plan has three main goals: enrollment stabilization (both academic and workforce), Gateway course completion, and credential attainment. We are pleased that we are already seeing results in the first year of implementation. Please note the following:

- A 4% increase in annualized FTE over the previous academic year.
- A 40% increase (as of April 24, 2023) in workforce enrollment over the previous academic year.
- The launch of a new CDL program.
- The opening of a new "Fab Lab" in Patrick County.
- The launch of a new C.N.A. pathway offered for dual enrollment students.
- The opening of a new powerline program in conjunction with Wytheville Community College.
- 72.4% completion rate for academic Gateway courses (Goal: 70%)
- 94.1% completion rate for workforce courses (Goal: 70%)
- An increase in total credentials earned from the previous year (830) to the current year (1004).

Because of Dr. Hodges' keen focus on our community's economic development and the college's vision of economic mobility for our citizens, Patrick & Henry Community College continues to receive national attention and accolades. Please note the following:

• P&HCC's Advanced Manufacturing program won the first Rural Community College Alliance (RCCA) Innovation and Access Award for its partnership with Festo Didactic and the National Coalition of Certification Centers (NC3).

- P&HCC was selected to become part of the first cohort of the MakerUSA Learning Network with 34 institutions and organizations across 20 states. The Learning Network is a national community of practice designed to facilitate the exchange of resources and ideas and strengthen collaboration across organizations that are taking a community-driven approach to "maker" education and career pathways into "maker" industries.
- Dr. Hodges was featured on the Ascendium Rural Matters podcast discussing the ways in which P&HCC is helping drive the economic renaissance occurring in our community.
- P&HCC is one of 17 colleges in the nation to be selected for the Achieving the Dream Community Vibrancy Cohort.
- "Startup and Grow Martinsville-Henry County" (our small business development programs offered in conjunction with the local Chamber of Commerce) has been selected by the Community Colleges of Appalachia as the recipient of the 2023 Workforce Development Award.
- P&HCC was heavily featured in the Aspen Institute publication entitled *Rural Community College Excellence: A Guide to Delivering Strong Opportunity for Students and Communities.*
- The college is one of 16 institutions across the country taking part in the Rural Pathways work with the National Center for Inquiry and Improvement (NCII).

While P&HCC is thrilled to receive such a tremendous amount of national attention, it is Dr. Hodges' focus on regional economic development that excites us the most. Recently, we opened the second building in our Manufacturing, Engineering, and Technology (the MET) Complex, a 103,000 square foot facility that is dedicated to good paying jobs in our service region. With programs such as mechatronics, engineering, CADD, robotics, precision machining, and the Racing College of Virginia, the MET has rightfully been referred to as our region's *Crown Jewel of Economic Development*. Students are already occupying our newly opened second building which triples our welding capacity. The grand opening of this facility is slated for early fall.

At the same time, Dr. Hodges has led the institution as it expanded our transfer partnerships and programs with our university partners and brought to scale new healthcare credentials (including a new C.N.A. lab) to meet the needs of our community. Further, P&HCC is a partner along with Longwood University and Virginia Western Community College in the \$1.45 million NSF Robert Noyce Teacher Scholarship Program which will help fill the pipeline of STEM teachers in our service region. Other local accomplishments shepherded by Dr. Hodges include the following:

- Awarded a grant from The Gene Haas Foundation for \$18,000.00 to support mechatronics scholarships and student competition teams.
- Received \$16,000 from ValleyStar Credit Union for scholarships and support of the motorsports program.
- Awarded \$43,000 from the Tobacco Commission to help cover the costs of credentialing embedded in academic programs.
- Received \$48,000 from Carter Bank & Trust to support workforce development.
- Awarded \$118,545 from Go Virginia Region 3 to fund welding instruction for dual enrollment students in Martinsville and Henry County.

Athletics has become an important part of the culture of Patrick & Henry Community College, and in this arena, President Hodges leads a tremendous staff. Our athletics department boasts the Region 10 soccer

champions as well as the number one runner in cross-country in the region who is also leading a recordbreaking cross-country team. P&HCC's outdoor track and field teams had many athletes qualify for nationals which is a first for our program. Additionally, our wrestling team sent seven wrestlers to the national tournament, the most in our history. In its first year of existence, our women's tennis team also sent three students to nationals.

While these athletic accomplishments are outstanding on their own, what we on the board are specifically proud of is the fact that President Hodges leads an athletics team that is focused on academics! More than half of our scholar-athletes posted GPAs greater than 3.0, and the entire student-athlete roster turned in an average GPA of 3.1 which exceeds the average GPA of the rest of the student body. Impressively, 33 of our athletes had perfect 4.0 GPAs. President Hodges leads an athletic department where success on the field is matched by success in the classroom!

Finally, Dr. Hodges remains dedicated to diversity and inclusion at P&HCC. Under his leadership, the diversity of P&HCC's employment base now exceeds that of the community we serve. The college has a rich history of identifying and closing student opportunity gaps, and Dr. Hodges remains demonstrably committed to these efforts. His relationships with our K-12 and university partners, business and industry leaders, and regional non-profits helps ensure that P&HCC remains squarely focused on the economic mobility of our students.

Our local board has been extremely pleased with Dr. Hodges this past year and we look forward to his continued leadership of Patrick & Henry Community College.

While that was definitely one of the most exciting moments of my year, there were many more successes I'm proud to celebrate this year.

That soccer championship wasn't the only first of this year. We had the number one runner in cross-country for the region in Alheli-Ramos Garcia, who went on to defeat every runner at the Region 10 XC Championships this Fall 2022. Our cross-country teams broke many school records. Our outdoor track and field programs had many qualify for nationals in Syracuse, NY, which are the first of our program. The P&H wrestling team sent seven wrestlers to the national tournament, the most in its history. These are triumphs that certainly show that P&H is growing and trending in an upward direction.

In October, Alheli Ramos-Garcia broke a program record in the women's 6K with a time of 25:19. Ramos-Garcia is also the school record holder in the women's 5k with a speedy time of 20:10, while freshman Riley Brim finished as P&HCC's top male with a time of 32:47.

Riley Brim earned All Region 10 honors while Alheli Ramos-Garcia raked in first place at the Region 10 Cross Country Championships, NJCAA Region 10 Division 3 Player of the Year, and was also named the Region 10 Runner of the Year.

This spring, our P&H golf program was able to secure the Region 10 Championship, along with the Region 10 Player of the Year (Ethan Cuddeback - Freshman), and Region 10 Coach of the Year (Coach James Draper) awards for Division 2. In the fall, the P&H golf team participated in four matches, accumulating one win and a second-place finish. Freshmen Ethan Cuddeback and Seth Moore received All-Tournament team honors during their fall season.

In year two of Coach Chris Mayshack's tenure with the men's basketball program, our Pats competed in the NJCAA Game of the Week on ESPN+ against Catawba Valley, while also having the chance to host the first round of Region 10 play. Redshirt freshman Jaylen Faber was able to walk away with Third Team All-Region 10 honors with 25 games played, an average of 13.9 point per game, 3.9 rebounds per game, and a 37.7% three-point percentage.

Women's Basketball, led by Coach Herb Daniel, also made it to the first round of Region 10 tournament play with an 11-14 record. Sophomore Ty'Nasia Witcher earned First Team All-Region 10 honors with 19 games played, an average of 25.1 points per game, 5.4 rebounds per game, and a solid 43.2% three-point percentage. Witcher also led the region and Division 2 NJCAA women's basketball in the leading scorer category.

After winning men's soccer's first Region 10 Championship this season, defender Carlos Trott, midfielder Chris Rosales Blanco and forward Enrique Jacobs all earned first team All-Region honors. Goalkeeper Martin Morse, defender Salvador Bernal Parra and midfielders Richard Salinas and Sean Paul Negron received 2nd team recognition. Kau Mendes was also an honorable mention. Coach Brennan Murphy received his fifth Region 10 Coach of the Year honor while sophomore Carlos Trott earned Region 10 Player of the Year for the season.

Under first year head coach and former P&HCC student athlete Arthur de Souza, the 2022 Lady Pats season concluded with a 9-0 defeat at the hands of Cape Fear CC in the Region 10 tournament on October 27. The Patriots finished their latest campaign with an overall record of 1-9-1, securing their lone victory 4-0 over Lenoir CC on September 27.

P&HCC midfielder Deon Cruickshank earned second team All-Region 10 honors, while goalkeeper Grace Webster was an honorable mention.

Under the leadership of first year head coach Brandi Woods, P&HCC's volleyball team finished the season with an overall record of 2-13 and a 2-8 mark in conference play. Both of the Patriots' victories came over Southwest Virginia CC, including a 3-0 sweep on September 8 and a thrilling five-set road match 3-2 on October 6. The Lady Pats were led by freshman middle blocker Emma Hankins, who earned second team All-Region 10 honors.
